

**COLUSA LOCAL AGENCY FORMATION COMMISSION
NOTICE OF PUBLIC HEARING AND
NOTICE OF INTENT TO WAIVE PROTEST PROCEEDINGS**

NOTICE IS HEREBY GIVEN by the Local Agency Formation Commission (LAFCo) that a Public Hearing will be held on **Thursday, July 9, 2026 at 3:00 p.m.** (or as soon thereafter as the matter may be heard) in the Colusa County Board of Supervisors Chambers at 546 Jay Street, Colusa, CA 95932, to consider adoption of a resolution approving the following:

City of Colusa Wastewater Treatment Plant (WWTP) #2 and Brookins Ranch Reorganization (LAFCo File 2024-0001). The proposal involves City of Colusa annexation and Sacramento River Fire Protection District (FPD) detachment of approximately 694.85-acres containing 10 Assessor Parcel Numbers (017-020-024, -025, -026, -027; 017-030-079, -080; and 015-130-128, -129, -068, -082) and portions of County public road right-of-way for Will S. Green Avenue and Wescott Road. The proposed annexation area is located southwest of the existing City limits and adjacent to the City's Wastewater Treatment Plant, as shown on the map on the reverse side of this notice. The annexation proposal includes detachment from the Sacramento River Fire Protection District.

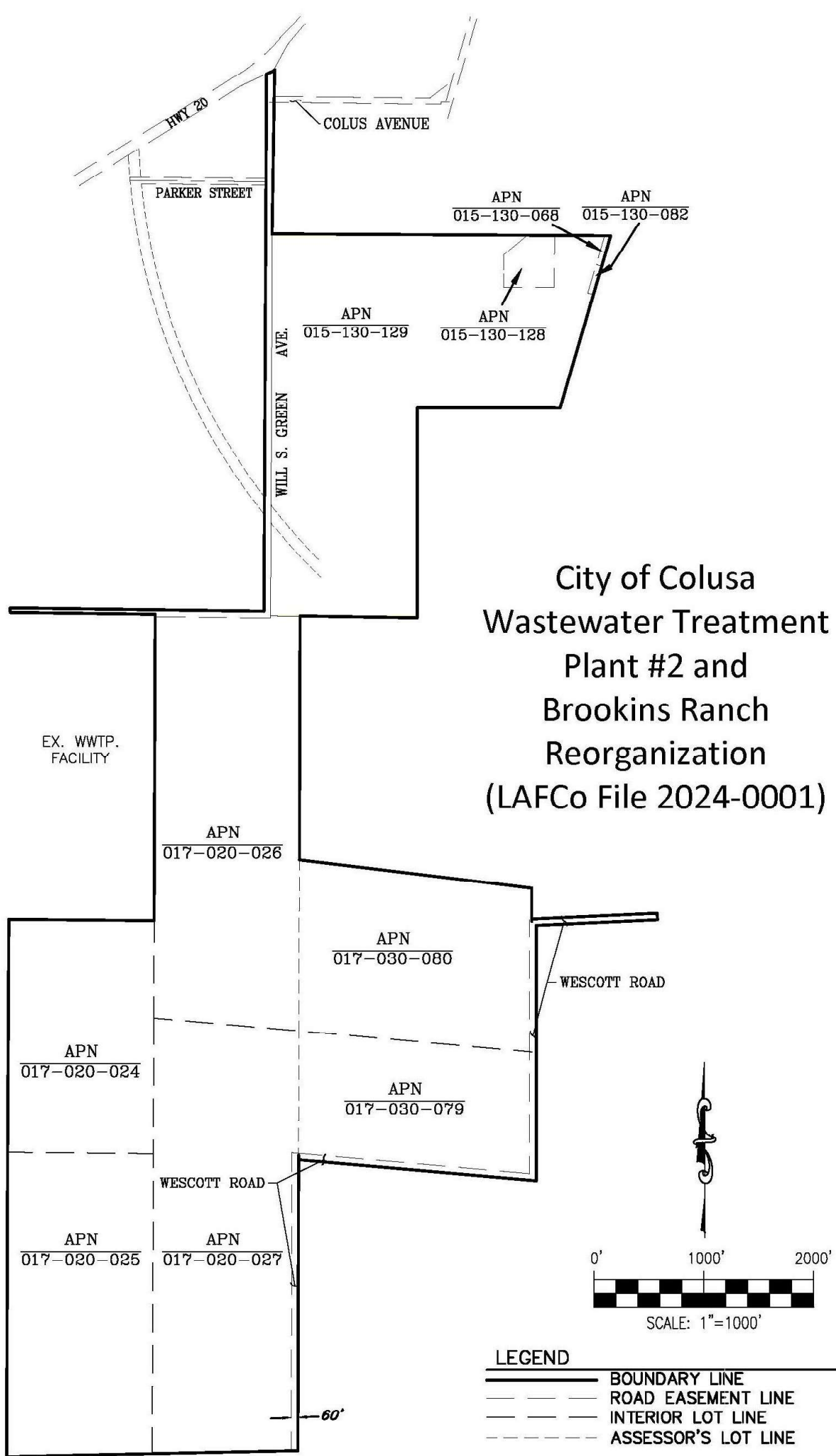
The City of Colusa, as Lead Agency under the California Environmental Quality Act (CEQA), approved a Mitigated Negative Declaration for the project (Wastewater Treatment Plant Annexation and Colusa Triple Crown Development - SCH #2026010040). LAFCo, as a Responsible Agency, will consider the environmental determination prepared by the City as part of its action.

NOTICE IS FURTHER GIVEN that LAFCo intends to waive Protest Proceedings pursuant to GOV Section 56663 unless written opposition to the proposal is received from landowners or registered voters within the affected territory before the conclusion of the Public Hearing on the proposal. Please be advised that if the proposal is approved, the affected territory is potentially subject to the extension or continuation of any previously authorized charge, fee, assessment, or tax by the City of Colusa and/or the Sacramento River FPD.

If you challenge the action of the Commission in court, you may be limited to raising only those issues you or someone else raised at the public hearing, or in written correspondence delivered at, or prior to, the public hearing described in this notice.

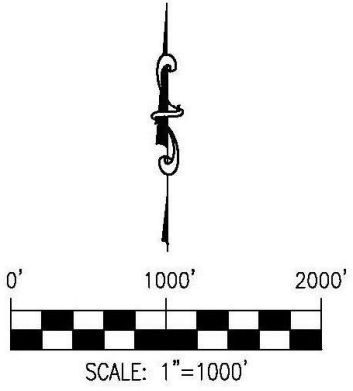
