2. Public Comment

The public may address the Commission on any matter within the jurisdiction of LAFCo which is not on the agenda. There is a three-minute limit, and no action will be taken.

PUBLIC HEARINGS:

3. City of Colusa Wastewater Treatment Plant (WWTP) #2 and Brookins Ranch Reorganization (LAFCo File 2024-0001)

Conduct a Public Hearing on the reorganization proposal involving City of Colusa annexation and Sacramento River Fire Protection District detachment of approximately 694.85-acres containing 10 Assessor Parcel Numbers (017-020-024, -025, -026, -027; 017-030-079, -080; and 015-130-128, -129, -068, -082) and portions of County public road right-of-way for Will S. Green Avenue and Wescott Road, and consider the following recommended actions:

- a. Acting as the Responsible Agency pursuant to the California Environmental Quality Act (CEQA), find that the [Mitigated Negative Declaration](#) (SCH No. 2026010040) adopted by the City of Colusa for the project was reviewed, considered, and determined to be adequate for the modified proposal.
- b. Adopt Resolution No. 2026-03, approving the LAFCo-modified City of Colusa WWTP #2 Reorganization (2024-0001) proposal subject to terms and conditions.
- c. Waive Protest Proceedings pursuant to GOV § 56663 unless written opposition to the proposal is received, and not withdrawn, from landowners or registered voters within the affected territory of the LAFCo-modified proposal before the close of the hearing.

4. Commissioner Reports - Discussion

Commissioner discussion of matters relevant to their constituency, LAFCo, and legislation.

5. Adjourn to the next regular LAFCo meeting on August 6, 2026 at 3:00 pm.

Any member appointed on behalf of local government shall represent the interests of the public as a whole and not solely the interest of the appointing authority (Government Code Section 56331.4).

Pursuant to Government Code Section 54954.2, Commissioners may make a brief announcement or report on activities. Commissioners may also provide staff a reference or resources for factual information, request staff to report back to the Commission at a subsequent meeting concerning a matter, or take action to direct staff to place a matter of business on a future agenda.

Public Comment

Members of the public may address the Commission on items not appearing on the agenda, as well as any item that does appear on the agenda, subject to the following restrictions:

- Items not appearing on the agenda must be of interest to the public and within the Commission's subject matter jurisdiction.
- No action shall be taken on items not appearing on the agenda unless otherwise authorized by Government Code Section 54954.2 (known as the Brown Act, or California Open Meeting Law).
- The total amount of time allotted for receiving public comments may be limited to 15 minutes.
- Any individual's testimony may be limited to 5 minutes. Time to address the Commission will be allocated on the basis of the number of requests received.

Public Hearings

Members of the public may address the Commission on any item appearing on the agenda as a Public Hearing. The Commission may limit any person's input to 5 minutes. Written statements may be submitted in lieu of or to supplement oral statements made during a public hearing.

Materials related to an item on this agenda submitted to the Commission after distribution of the agenda are available for review for public inspection on the Colusa LAFCo website as noted above to the extent practicable and subject to staff's ability to post the documents prior to the meeting.

An interpreter for the hearing-impaired may be made available upon request to the Executive Officer 72 hours before a meeting. The location of this meeting is wheelchair accessible.

Disclosure & Disqualification Requirements

Pursuant to Government Code Sections 56100.1, 56300(b), 56700.1, and 81000 et seq., and Colusa LAFCo's Policies and Procedures for the Disclosure of Contributions and Expenditures in Support of and Opposition to Proposals, any person or combination of persons who directly or indirectly contribute \$1000 or more or expend \$1000 or more in support of or opposition to a change of organization or reorganization that has been submitted to Colusa LAFCo must comply with the disclosure requirements approved by Colusa LAFCo. These requirements contain provisions for making disclosures of contributions and expenditures at specified intervals. A LAFCo Commissioner must disqualify herself or himself from voting on an application involving an "entitlement for use" (such as an annexation or sphere amendment) if, within the last twelve months, the Commissioner has received \$250 or more in campaign contributions from the applicant, any financially interested person who actively supports or opposes the application, or an agency (such as an attorney, engineer, or planning consultant) representing the applicant or an interested party. The law (Government Code Section 84308) also requires any applicant or other participant in a LAFCo proceeding to disclose the contribution amount and name of the recipient Commissioner on the official record of the proceeding.
