Disclosure & Disqualification Requirements

Pursuant to Government Code Sections 56100.1, 56300(b), 56700.1, and 81000 et seq., and Colusa LAFCO's Policies and Procedures for the Disclosure of Contributions and Expenditures in Support of and Opposition to Proposals, any person or combination of persons who directly or indirectly contribute \$1000 or more or expend \$1000 or more in support of or opposition to a change of organization or reorganization that has been submitted to Colusa LAFCO must comply with the disclosure requirements approved by Colusa LAFCO. These requirements contain provisions for making disclosures of contributions and expenditures at specified intervals. Additional information may be obtained at the Colusa County Elections Department 546 Jay Street, Colusa, CA 95932. (530) 458-0500

A LAFCO Commissioner must disqualify herself or himself from voting on an application involving an "entitlement for use" (such as an annexation or sphere amendment) if, within the last twelve months, the Commissioner has received \$250 or more in campaign contributions from the applicant, any financially interested person who actively supports or opposes the application, or an agency (such as an attorney, engineer, or planning consultant) representing the applicant or an interested party. The law (Government Code Section 84308) also requires any applicant or other participant in a LAFCO proceeding to disclose the contribution amount and name of the recipient Commissioner on the official record of the proceeding.

Ben stated the district is central to irrigation and drainage and gave the Commission some historical context on the area.

3. Public Comment:

Ben King, landowner, stated the General Manager for SOI GCID has resigned. He also made a correction in his assumption of the salt load regarding the contamination of ground water at the Colusa and Sacramento Refuge.

5. Correspondence:

John Benoit explained the upcoming CALAFCo Conference agenda has been sent out.

6. Colusa Basin Drainage District (CBDD)

John Benoit asked Counsel to make determination as to Colusa LAFCO's specific jurisdiction and obligations regarding the Colusa Basin Drainage District.

John Benoit stated he would be Inviting the Colusa Basin Drainage District General Manager to a future LAFCO Meeting.

Ben King explained the need to have a MSR and SOI Update prepared.

7. Colusa County Water District Annexation and Minor Sphere Amendment (File 2023-0001).

John Benoit gave a summary of the Executive Officer Report

Shelly Murphy explained the Colusa County Water District's capacity to provide water.

Public Hearing:

Ben King questions whether there is adequate water supply and expressed concern of adding acreage to the district. He raised the question of inadequate notification to neighbors and wonders about the 218 ramifications.

Shelly Murphy explained the applicants were the ones to reach out to the district and explained others have the same opportunity to submit a letter to the district.

### Action:

- Upon motion of Commissioner Bell and seconded by Commissioner Corona, the commission unanimously voted to approve LAFCO Resolution 2023-0006 adopting a 123.32 acre Sphere of Influence Amendment for Colusa County Water District
- 2. Upon motion of Commissioner Ponciano and seconded by Commissioner Bell, the commission unanimously voted to approve LAFCo Resolution 2023-0007 annexing 758 acres more or less to the Colusa County Water District.
- 8. Executive Officer's Report:
  - a. Williams Service Review John Benoit stated staff is working on a Municipal Service Review for Williams.
  - b. Calafco Conference John Benoit briefed the commission on the upcoming CALAFCo Conference.

9. Commissioner Reports:

Scott Brown, LAFCO Counsel explained there is a new proposition on the November ballot, and if passed will affect LAFCO annexations in the future. The proposition is intended to further Prop 218 to fill in loopholes that have been used and would require any geographical extension into a district (that already has a special tax ) to be conditioned upon a Prop 218.

**RE:** Whether The Colusa Basin Drainage District is a Special District Subject to LAFCo Authority for All Changes of Organization Other than Formation

You have requested that I research the legal authority of LAFCo to approve changes of organization for the Colusa Basin Drainage District (Hereinafter "the District"). If so, then does LAFCo also have responsibility to prepare an MSR and Sphere of Influence for the District?:

My conclusion is that under the special legislation that created the District, the Colusa Basin Drainage Act ("the Act") the Cortese-Knox-Hertzberg Local Government Reorganization Act of 2000 (CKH) and applicable caselaw, the Colusa Basin Drainage District is a special district subject to LAFCo authority for all changes of organization other than formation. Because it is subject to LAFCo authority, LAFCo has an obligation to prepare an MSR and Sphere of Influence for the District,

The District was created by special legislation in 1987, and is set out in Chapter 127 of the Water Appendix. The stated purpose for the district is "to study, plan, and facilitate the implementation of plans, as specified in Chapter 2 (commencing with Section 610) of Part 6, leaving, wherever possible, the implementation of the plan to the local agency or other district which is best able to carry out that function. (Section 127-413) Nevertheless the District is given broad powers under the Act to establish water works and drainage facilities.

The formation of the District was expressly exempted from CKH and LAFCo approval. But the applicable language in the Act states the limited scope of the exemption as follows:

Sec.127- 50. The Cortese-Knox Local Government Reorganization Act of 1985 (Division 3 (commencing with Section 56000) of Title 5 of the Government Code) does not apply to the formation of the district or the formation or changes in the boundaries of any zone. For all other purposes, the district is a "district" as that term is defined in the Cortese-Knox Local Government Re§ 127-51. Judicial actions or proceedings; limitations

In the case of *Las Tunas Beach Geologic Hazard Abatement Dist. v. Superior Court (City of Malibu)* (1995) 38 Cal. App. 4th 1006] the Court of Appeal was asked to address the application of CKH to dissolution of a geologic hazard abatement district (GHAD) created by special legislation. As with the

District here, the legislation for the GHAD provided for formation of the district without LAFCo involvement but was silent as to any further exemption from CKH. The City of Malibu had attempted to dissolve the district on its own, relying on its "common law" general authority. The Court of Appeal rejected that approach, saying:

The City's reliance on these common law theories is misplaced. A GHAD is purely a creature of statute, unknown at common law. Further, Cortese-Knox expressly states it is "the sole and exclusive authority and procedure" for changes of organization, including district dissolution. (Gov. Code, §§ 56100, 56021, subd. (e).) The Legislature thus has evidenced its intention that Cortese-Knox provide the exclusive method for such changes of organization. (See Ferrini v. City of San Luis Obispo, supra, 150 Cal.App.3d at p. 247.) Therefore, the City's effort to enforce its home-grown formation condition pursuant to common law doctrines "interferes with and frustrates state [dissolution] procedures and cannot be sustained." (L.I.F.E. Committee v. City of Lodi, supra, 213 Cal.App.3d at p. 1148.)

We conclude the Public Resources Code's silence with respect to GHAD dissolution requires resort to Cortese-Knox, not to common law theories. [38 Cal. App. 4th 1012]

It would appear Cortese-Knox complements the statutory schemes pertaining to specific types of districts, such as GHAD's, by supplying the necessary procedures for changes of organization and thereby filling any gaps in the legislative scheme. fn. 7

We have a very similar situation here with respect to the Colusa Basin Drainage District. The statute exempts the formation of the district but is even clearer that for all other purposes the District "is a *"district" as that term is defined in the Cortese- Knox Local Government Act" (Water Code Appendix Section 127-50).* Under the Las Tunas decision and this statutory provision it is clear that the District is subject to LAFCo jurisdiction for all other changes of organization just like any other special district. As such, it is subject to the mandate of Gov't C §56425 and 56430 which require LAFCo to develop a sphere of influence and prepare a Municipal Services Review for the District.

I trust this clarifies LAFCo's responsibility with regard to the Colusa Basin Drainage District,
