Disclosure & Disqualification Requirements

Pursuant to Government Code Sections 56100.1, 56300(b), 56700.1, and 81000 et seq., and Colusa LAFCO's Policies and Procedures for the Disclosure of Contributions and Expenditures in Support of and Opposition to Proposals, any person or combination of persons who directly or indirectly contribute \$1000 or more or expend \$1000 or more in support of or opposition to a change of organization or reorganization that has been submitted to Colusa LAFCO must comply with the disclosure requirements approved by Colusa LAFCO. These requirements contain provisions for making disclosures of contributions and expenditures at specified intervals. A LAFCO Commissioner must disqualify herself or himself from voting on an application involving an "entitlement for use" (such as an annexation or sphere amendment) if, within the last twelve months, the Commissioner has received \$250 or more in campaign contributions from the applicant, any financially interested person who actively supports or opposes the application, or an agency (such as an attorney, engineer, or planning consultant) representing the applicant or an interested party. The law (Government Code Section 84308) also requires any applicant or other participant in a LAFCO proceeding to disclose the contribution amount and name of the recipient Commissioner on the official record of the proceeding.

- 6. Public Hearing regarding Reclamation, Levee and Flood Control Districts MSR and SOI (hard copies handed out at the June 7, 2018 LAFCo meeting)

3:08 - Opened Public Hearing

John presented the Executive Officer's memo stating that the MSR and SOI were distributed at the June 2018 meeting and reviewed at the July 2018 meeting. Several comments were brought up, and he stated that the following paragraph will be added to Section 2.1.1 on page 11:

"When Shasta Dam was built in the late 1940s, the newly constructed Central Valley Project created uncertainty for the historic water users on the Sacramento River. The issue was that the stored water from the reservoir was comingled with the rivers natural flows. The stored water was considered to be property of the Bureau of Reclamation (USBR) and the natural flows included the water rights of historic water users. In 1964 USBR entered into a water right Settlement Contract with Sacramento River Water Users that preserved their prior and historic water rights and provided for some supplemental water during the

summer months from the Central Valley Project. RD 108 has a 232,000 acrefoot under this USBR contract that covers April 1 through October 31. The District also has a winter water right and other senior water rights and riparian water rights that cover the winter months for decomposed rice straw and winter floodplain habitat."

John spoke with Terry Bressler at RD 1004 and he indicated the RD 1004 Board of Directors does not desire to annex other territory into its district at this time. Therefore, the RD 1004 SOI map is to remain as proposed.

The addresses and phone numbers for members of the District Board of Directors shall be removed throughout the document (pg. 37).

3:15 - closed Public Hearing

Commissioner B. Ash moved to approve Resolution 2018-0007, the Municipal Service Review for Reclamation, Flood Control, and Levee Districts in Colusa County and Resolution 2018-0008, the Sphere of Influence update for Reclamation, Flood Control, and Levee Districts in Colusa County, second by Commissioner A. Sellers, Jr., motion carried by roll call vote.

There are 7 fire districts in Colusa County, and data is needed from each district. Do we want to see consolidation of fire districts? Further discussion was held regarding JPAs, the cost of services, insurance coverage, and how board members are chosen. K. Boes asked if John wanted to meet with all of the Fire Chiefs. John responded yes, he would like to meet and distribute the reviews. John will get a list of contacts and go from there.

Subject: Possible Dissolution of Four Special Districts as a Result of SB 448

Dear John:

This letter is in response to your January 7, 2019, "possible dissolution" letter for the following four special districts:

- Century Ranch Water District
- CSA #3
- Hazel Court CSA
- Colusa County Flood Control and Water Conservation District

We understand the State Controller provided LAFCO with a list of possible inactive special districts and it is the Commission's duty to determine if the districts meet the criteria set forth in Government Code 56042, which states:

56042. "Inactive district" means a special district that meets all of the following:

- (a) The special district is as defined in Section 56036.
- (b) The special district has had no financial transactions in the previous fiscal year.
- (c) The special district has no assets and liabilities.
- (d) The special district has no outstanding debts, judgments, litigation, contracts, liens, or claims.

Based on the definition of an "inactive district", we agree that the following two special districts are inactive:

- Century Ranch Water District
- Hazel Court CSA

However, based on the same Government Code, the two remaining special districts are still "active".

The Colusa County Flood Control and Water Conservation District has been active for decades. As proof of the district's active status, I have enclosed the following documentation for 2016-17, 2017-18, and 2018-19 fiscal years.

1. Board Agenda for the Budget Public Hearing

2. Signed Board Resolution Adopting the District's Budget and the related Exhibit

3. Revenue and Expenditure Status Reports

I have also enclosed a June 30, 2018 Balance Sheet that shows the District has a \$300 cash balance.

As evidenced by these financial documents, the Colusa County Flood Control and Water Conservation District is considered "active". The district does not meet the definition of an "inactive district" pursuant to Government Code 56042(b) or 56042(c) and should not be dissolved.

The CSA #3 has been active since it was formed in 1989 to address health and safety issues related to contaminated private wells. Although this special district has not necessarily had any annual financial activity, pursuant to 56042(d) it is an "active" district because it has an outstanding contract. I have enclosed the 1991 agreement between the City of Colusa and CSA #3, "Agreement for the Operation, Maintenance, Financing and Use of Colusa County CSA No. 3 Water System".

CSA #3 was formed to obtain financing through various sources to build infrastructure connected to City water supplies. To that end, the CSA entered into a 50 year agreement with the City to have the City manage and construct the necessary infrastructure. In exchange, the CSA provided the City with \$59,000 for the project. Under the terms of the agreement the City is required to make charges and provide the CSA with excess revenues. (See Section 4.1 of the Agreement). Additionally, the City is required to provide reports, receipts and accounting an annual basis. (See Section 6.1 of the Agreement). The contract does not terminate until 2040 or until the area is annexed into the City; which has not occurred. The CSA #3 contract with the City of Colusa for the operation and maintenance of the water infrastructure is considered an asset. Therefore, the district does not meet the definition of an "inactive district" pursuant to Government Code 56042(c) or 56042(d) and should not be dissolved.

Please advise if you require additional documentation prior to the February 7th LAFCO meeting. I want to ensure the Commission has sufficient evidence that the Colusa County Flood Control and Water Conservation District and the CSA #3 are "active" special districts and should not be dissolved.

Subject: Possible Dissolution of the Century Ranch Water District, CSA #3, Hazel Court CSA and the Colusa County Flood Control and Water Conservation District

Dear Peggy and Scott:

The Colusa Local Agency Formation Commission (LAFCo) received the two attached letters from the State Controller's Office (SCO) regarding the dissolution of the Century Ranch Water District, CSA #3, Hazel Court CSA and the Colusa County Flood Control and Water Conservation District. Last year, SB 448 was signed into law by the Governor requiring the SCO to create a list of "inactive" special districts and mandating LAFCo's to dissolve districts that have not completed an audit.

The California Association of LAFCo's and the California Special District's Association were successful in amending SB 448 to include a definition of an "inactive special district" but were not successful in defeating the legislation.

As required in SB 448, LAFCo is now mandated to dissolve the Century Ranch Water District, CSA #3, Hazel Court CSA and the Colusa County Flood Control and Water Conservation District unless the district is able to provide evidence that the Districts have had financial transactions in the previous fiscal year (2016-2017 or 2017-2018), the Districts have assets and liabilities, and the Districts have outstanding debts, judgments, litigation, contracts, liens or claims.

LAFCo is requesting the district provide information demonstrating the Century Ranch Water District, CSA #3, Hazel Court CSA and the Colusa County Flood Control and Water Conservation District are not in fact inactive by providing the information stated above.

LAFCo is required to initiate dissolution of the district within 90 days of receipt of the SCO's letter unless LAFCo determines the district does not meet the requirements in

G.C. 56042. At this time, LAFCo intends on placing an item to discuss the timeline to initiate dissolution of the districts or to respond to the SCO at its next agenda scheduled for February 7, 2019.

Dear Mr. Benoit:

Chapter 334, Statutes of 2017 (Senate Bill 448) added various provisions to the Cortese-Knox-Hertzberg Local Government Reorganization Act of 2000 regarding special districts that are inactive. SB 448 requires the State Controller's Office (SCO) to create a list of inactive special districts based on information in the special district's Financial Transactions Reports (FTR), publish the list of inactive special districts on its website annually, and notify a local agency formation commission in the county or counties in which the inactive special district is located.

Pursuant to Government Code (GC) section 56042, an "inactive special district" meets all of the following:

- (a) The special district is as defined in Section 56036.
- (b) The special district has had no financial transactions in the previous fiscal year.
- (c) The special district has no assets and liabilities.
- (d) The special district has no outstanding debts, judgments, litigation, contracts, liens, or claims.

Within 90 days of receiving this notice, the commission is required to initiate dissolution of inactive special district(s), unless you determine that the district(s) does not meet the criteria set forth in GC section 56042. The commission shall also notify the SCO if you determine that the district(s) does not meet the criteria set forth in GC section 56042.
