Pursuant to Government Code Sections 56100.1, 56300(b), 56700.1, and 81000 et seq., and Colusa LAFCO's Policies and Procedures for the Disclosure of Contributions and Expenditures in Support of and Opposition to Proposals, any person or combination of persons who directly or indirectly contribute \$1000 or more or expend \$1000 or more in support of or opposition to a change of organization or reorganization that has been submitted to Colusa LAFCO must comply with the disclosure requirements approved by Colusa LAFCO. These requirements contain provisions for making disclosures of contributions and expenditures at specified intervals. A LAFCO Commissioner must disqualify herself or himself from voting on an application involving an "entitlement for use" (such as an annexation or sphere amendment) if, within the last twelve months, the Commissioner has received \$250 or more in campaign contributions from the applicant, any financially interested person who actively supports or opposes the application, or an agency (such as an attorney, engineer, or planning consultant) representing the applicant or an interested party. The law (Government Code Section 84308) also requires any applicant or other participant in a LAFCO proceeding to disclose the contribution amount and name of the recipient Commissioner on the official record of the proceeding.

8. Executive Officer's Report

- a. SB 414 did not pass the Assembly Appropriations Committee John stated that this is the water district the state is trying to set up; would circumvent Lafco and be a very expensive process for us. According to Calafco it will be back next year.
- b. Update City of Colusa Reorganization (2019-0001) annexation of CIP land; in process. There is a lot of information, including a signed application form, still needed before it can be processed.
- c. Proposed Wilson annexation and Subdivision to the City of Colusa located on 5th Street in Colusa John stated that because we do not want to create islands, we should consider including additional properties in that area. The City met with landowners and there was some interest in annexation. The city is working on it.
- d. City of Colusa MSR and SOI update (last adopted in 2011) Time to update.
- e. City of Williams MSR and SOI (last adopted 2013) Will follow the City of Colusa update
- J. Loudon stated that the tax-sharing agreement has been approved by the county. The city has also approved the agreement. John responded that when the city submits their application, the agreement will be included. However, they do need maps and descriptions. The tax-sharing agreement is usually what holds up an application. Because it has been completed, the Lafco process should go quickly, not withstanding the state-mandated timelines, which do slow the process down. John is concerned about the fire district with this project.
- 9. Commissioner Reports Discussion J. Loudon stated that the City and County are going to start meeting on the SOI since the CIP annexation.
 - S. Singh stated that he talked with the City of Williams Planner regarding the MSR and SOI and put it on the calendar.

Approving a Municipal Service Review of Fire and EMS Services Provided within Colusa County and Adopting Written Determinations Thereon

WHEREAS, California Government Code Section 56425 requires that a Local Agency Formation Commission ("LAFCO") adopt and periodically review Sphere of Influence Plans for all agencies in its jurisdiction; and,

WHEREAS, California Government Code Section 56430 requires that a LAFCO conduct a review of the municipal services provided by and within an agency prior to updating or adopting its Sphere of Influence Plan; and.

WHEREAS, the Sphere of Influence Plan is the primary planning tool for LAFCO and defines the probable physical boundaries and service area of a local agency as determined by LAFCO; and,

WHEREAS, on June 3rd, 2004, the Commission adopted its Work Plan and included a schedule for initiation of Municipal Service Reviews (MSRs) and Spheres of Influence; and

WHEREAS, the Commission adopted Resolution 2004-03 on March 4th, 2004 establishing guidelines for conducting MSRs, which applies to this MSR for services provided by fire protection agencies within Colusa County; and,

WHEREAS, at the time and in the manner provided by law, the Executive Officer gave notice of the date, time, and place of a public hearing by the Commission for fire and EMS services provided within Colusa County, including approval of the report and adoption of the written determinations contained therein; and,

WHEREAS, the Commission hereby determines that the hearing draft of the Municipal Service Review for fire and EMS services provided within Colusa County and written determinations contained therein will provide information for updating the Sphere of Influence for fire protection districts and cities within Colusa County, and is otherwise consistent with the purposes and responsibility of the Commission for planning the logical and orderly development and coordination of local governmental agencies so as to advantageously provide for the present and future needs of the county and its communities; and,

WHEREAS, in making this determination, the Commission has considered the documentation on file in this matter; and.

WHEREAS, the Commission has heard all interested parties desiring to be heard and has considered the proposal and report by the Executive Officer and all other relevant evidence and information presented at said hearing;

NOW, THEREFORE, the Local Agency Formation Commission of Colusa County hereby resolves, orders and determines the following:

- 1) The Municipal Service Review for Fire and EMS Services provided in Colusa County, attached hereto as Exhibit A, is approved and the written determinations presented in the Municipal Service Review report are hereby adopted.
- 2) LAFCO staff is further ordered to proceed as appropriate with update to the Sphere of Influence Plan for Fire Protection and EMS services.

3) LAFCO staff is further ordered to forward copies of this resolution containing the adopted Municipal Service Review to all fire agencies within Colusa County and specifically, the City of Colusa, the Williams Fire JPA, the Arbuckle-College City Fire Protection District, the Bear Valley- Indian Valley Fire Protection District, the Sacramento River Fire Protection District, the Princeton Fire Protection District and the Maxwell Fire Protection District.

A Resolution Making Determinations and Approving a Fire and EMS services Sphere of Influence Update for the Williams Rural Fire Protection District, the Arbuckle-College City Fire Protection District, the Bear Valley-Indian Valley Fire Protection District, the Sacramento River Fire Protection District, the Princeton Fire Protection District and the Maxwell Fire Protection District

WHEREAS, Government Code Section 56425 requires each Local Agency Formation Commission to adopt and periodically review and update a Sphere of Influence for each local governmental agency within its jurisdiction; and

WHEREAS, the Colusa Local Agency Formation Commission, in compliance with the aforementioned requirement, is providing a "plan for the probable physical boundaries and service area" for fire and emergency medical services provided by the Williams Rural Fire Protection District, the Arbuckle-College City Fire Protection District, the Bear Valley-Indian Valley Fire Protection District, the Sacramento River Fire Protection District, the Princeton Fire Protection District and the Maxwell Fire Protection District; and

WHEREAS, the Commission has set the hearing date of October 1, 2020 and November 5, 2020 for the update for fire and emergency medical services provided by the Williams Rural Fire Protection District, the Arbuckle-College City Fire Protection District, the Bear Valley-Indian Valley Fire Protection District, the Sacramento River Fire Protection District, the Princeton Fire Protection District and the Maxwell Fire Protection District, and has noticed this hearing at the times and as otherwise prescribed by Government Code Section 56427, et seq.; and

WHEREAS, the Commission has heard and adopted a Municipal Services Review of fire and emergency medical services provided by the Williams Rural Fire Protection District, the Arbuckle-College City Fire Protection District, the Bear Valley-Indian Valley Fire Protection District, the Sacramento River Fire Protection District, the Princeton Fire Protection District and the Maxwell Fire Protection District, and adopted Resolution 2020-0004 on November 5, 2020 in accordance with Gov. Code section 56430; and

WHEREAS, the Commission has reviewed and considered the proposed Sphere of Influence update report and the proposed Sphere of Influence Update Map which are attached hereto and incorporated herein; and

WHEREAS, Colusa LAFCO has prepared and published a Notice of Exemption pursuant to the requirements of the California Environmental Quality Act since the Sphere of Influence Update will not contain additional territory (Section 21000 et seq. of the Public Resources Code); and

WHEREAS, the Commission has considered those factors determined by it to be relevant to the proposed Sphere of Influence Update, including, but not limited to, those factors specified in Government Code Section 56425, et seq., and has heard from interested parties and considered requests for amendment and/or revision of the proposed updated sphere boundary, if any;

NOW, THEREFORE, BE IT RESOLVED that the Colusa Local Agency Formation Commission does hereby find and determine as follows:

Colusa Local Agency Formation Commission Resolution # 2020-0005: Fire District Sphere Update October 1, 2020

- 1. That the Sphere of Influence update with respect to for fire and emergency medical services provided by the Williams Rural Fire Protection District, the Arbuckle-College City Fire Protection District, the Bear Valley-Indian Valley Fire Protection District, the Sacramento River Fire Protection District, the Princeton Fire Protection District and the Maxwell Fire Protection District, complies with the provisions of Government Code Section 56000, et seq.
- 2. That no significant objections have been received regarding the establishment of this Sphere of Influence Update.
- 3. That, pursuant to Government Code Section 56425, the Commission makes and adopts those determinations set forth in the Sphere of Influence Update Study are attached hereto and incorporated herein as set forth in Attachment "A".
- 4. The Sphere Influence Update for the Glenn-Colusa Fire Protection District is the responsibility Glenn LAFCO. The Sphere of Influence update for territory within this district yet within Colusa County is solely the responsibility of Glenn LAFCO.
- 5. The Commission has reviewed and considered a Notice of Exemption prepared for this Sphere of Influence Update and makes a specific finding that there is no substantial evidence in light of the whole record before Colusa Local Agency Formation Commission and no unusual circumstances existing that this Sphere of Influence Update for fire and emergency medical services provided by the Williams Rural Fire Protection District, the Arbuckle-College City Fire Protection District, the Bear Valley-Indian Valley Fire Protection District, the Sacramento River Fire Protection District, the Princeton Fire Protection District and the Maxwell Fire Protection District, may have a significant adverse effect on the environment.

Regular meetings of the Commission are scheduled for the first Thursday of every month at 3:00 p.m. in the Board of Supervisor's Chambers, 546 Jay St, Colusa, California. The Commission may, at its own discretion, meet at a different time or place from time to time, provided that public notice of such time and place is given in accordance with the Open Meeting Law, Government Code Section 54954 and applicable provisions of the LAFCO Act.

The Chair or Executive Officer may call a special meeting of the Commission. The Chair shall call a special meeting if requested by two or more Commissioners. Any special meetings of the Commission shall be called in the manner provided by Section 54956 of the Government Code. The order calling the special meeting shall specify the time and place of the meeting and the business to be conducted and no other business shall be conducted at that meeting. The special meeting may be called for any day prior to the date established for the next regular meeting of the Commission.

ANNEXATIONS LOCAL AGENCY FORMATION COMMISSION (LAFCO) PROCESS

1. Pre-Application

Meet with the LAFCO Executive Officer to review the annexation proposal, LAFCO's application requirements, and to determine whether any "red flags" must be addressed such as a Sphere of Influence Amendment.

If for a County Service Area, Board of Supervisors must adopt resolution of application

2. Application

Submit signed resolution and signed application to LAFCO

Must include map and geographic description prepared by a Public Land Surveyor to be approved by the County Surveyor and corrected as necessary.

Prepare property tax exchange agreement (could take up to 105 days, or more)

Include plan for providing services (and fiscal analysis, if required)

Include showing of General Plan consistency, Prezoning and CEQA documentation including a Notice of Exemption or Notice of Determination

Include CEQA documentation and Pre-annexation and annexation agreement.

LAFCO fee deposit

3. LAFCO Review

Acceptance of Resolution or Petition of application

Send referral letters to the Assessor, Auditor, Elections and affected agencies for specific information

Review application for completeness once submitted (30 days allowed)

Prepare Certificate of Filing – Public Notice for hearing – 21 day published hearing notice, as applicable. Notify all affected agencies and meet Public notice requirements.

Executive Officer prepares report and recommendation 5-days prior to the hearing.

LAFCO adopts a resolution with terms and conditions to be met.

Public Protest Hearing on applications without 100% consent) to determine whether the proposed annexation must be terminated, approved with or without an election, to determine the proposal's outcome.

4. Post-Hearing

Record Certificate of Completion (Effective date is the date the certificate is recorded unless LAFCO has established a different effective date.)

File annexation with the State Board of Equalization (in most cases)

Notify all affected agencies.

Public notice requirements

5. Timeline (minimums)

30-day minimum application review once a complete application has been received and signed. May take longer for map and description review and will take longer for PT Exchange Agreement. Without an adequate map the public notice list will not be accurate.

21-day public notice for application

After 30 days may record certificate of completion provided all terms and conditions are met, a request for reconsideration has not been received and conducting authority proceedings have been waived.

6 The Commission may amend any proposal
